DIRECTOR'S REPORT

- One trainee has been released and is working on own shift; doing well. A second trainee, now registered for EMD after difficulties with registration prior. Should be ready to release onto own shift pending successful completion of EMD. New hire, with experience, needs to certify in CPR & EMD prior to release from training onto own shift. One open position; currently working with HR.
- Question posed if dispatchers could utilize the county provided CPR Stop the Bleed training. Director Scamehorn advised BLS CPR is required for dispatcher compliance with state standards.
- NESCA conference located in Kearney in April; two staff members will be attending.
- National NENA conference scheduled for Long Beach, CA; registration opens soon.

 - o Does not qualify for Drug Fund expenditure.

Initial quote provided at October 24,2024 meeting has been reduced by over 10% due in part to York and Butler Counties already having purchased the program. This is being offered as a fixed annual rate.
