### **Commissioner Reports:**

Commissioner Pekarek reported he met with the Veterans Service Committee, checked inventories of various departments, met with the Assessor, attended a virtual Emergency Preparedness meeting, and attended the Seward County Post Card Hearing.

Commissioner Schmieding reported he checked inventories of various departments, will attend a Blue Valley Community Action (BVCA) meeting, a Visitors Bureau meeting, and a Seward City Recreational Department meeting. He also attended the Seward County Post Card Hearing.

Commissioner Ahmic reported she completed her checks of various departments' inventories, met with the Zoning Administrator, had an infrastructure meeting with producers along with Commissioner Zabrocki, attended a virtual Emergency Preparedness event meeting, and attended the Seward County Post Card hearing.

Commissioner Zabrocki reported he attended a Seward city council meeting, attended an infrastructure meeting with producers along with Commissioner Ahmic, attended a SouthEast Nebraska Development District (SENDD) board meeting, attended a POW MIA Program at the National Guard Museum, attended the Seward County Post Card hearing and completed checks of inventories for various departments.

Commissioner Hain reported she completed inventory checks for various departments, but has one left, attended a presentation at St. John hosted by St. John and Four Corners Health Dept, spoke to Beth Ferrell from Nebraska Association of County Officials (NACO) about a legislative bill, has been in contact with Senator Hughes, met with the Detention Center Director, assisted with set up and then attended the Seward County Post Card hearing, and received a call regarding a culvert replacement project.

Marissa Pfile, Zoning Administrator, was present for the discussion regarding the resolution to clarify Resolution No. 3880 for a Conditional Use Permit for Pine Creek Poultry, LLC in the SE ¼ of Section 7, Township 12 North, Range 2 East of the 6th P.M.

Andrew Spader, an attorney representing Pine Creek Poultry was also present for the discussion.

Moved by Zabrocki and seconded by Hain to enter into Executive session at 9:02 a.m. to discuss Resolution #3880 and seek advice from legal counsel.

The Chair stated that the reason for Executive Session was to seek advice from legal counsel regarding Resolution #3880.

Moved by Zabrocki and seconded by Pekarek to come out of Executive Session at 9:36 a.m.

The chair announced that during executive session, legal advice was reviewed, and no action was taken.

The Commissioners Recessed at 9:36 a.m. The Commissioners Reconvened 9:40 a.m.

Commissioner Ahmic stated that, based on the discussion during executive session, the resolution to clarify Resolution #3880 for a Conditional Use Permit for Pine Creek Poultry, LLC in the SE ¼ of Section 7, Township 12 North, Range 2 East of the 6th P.M. was being tabled at this time.

Tom Nesbitt and Matthew Sutter of Nesbitt & Associates were present to discuss the review of the independent audit their company performed for the Seward County Drug Seized Asset Forfeiture Funds for both the County Attorney's Office and the Sheriff's Office.

The audit of the County Attorney's funds was conducted at the request of the Commissioners for the period from July 1, 2023 to February 28, 2025. The activity of the County Attorney drug seizure asset forfeiture accounts was reviewed. The County Attorney's Office receives asset forfeiture revenue through Treasury and Justice funds. These funds are restricted by law to be used for law enforcement purposes, and they must supplement, not supplant, the regular budget. It was noted that the main expenditure of these funds was for compensation to the Special Deputy County Attorney for salary, FICA contributions, and retirement contributions. The review of these funds showed the following:

- 1. Necessity of Expenses All expenditures were reasonable and directly tied to prosecuting drug trafficking and related criminal cases.
- 2. No Supplanting of Budget Forfeiture funds were not used to replace or offset the County Attorney's normal operating budget. Funding for the Special Deputy position was appropriately supported by drug seizure revenues.
- 3. No fraud or Mismanagement No evidence of fraud, misappropriation, or intentional mismanagement was identified. All reviewed transactions had supporting documentation

In conclusion, the audit highlights that the Seward County Attorney's Office demonstrates a strong record of compliance with state and federal asset forfeiture requirements. No corrective action is required.

The audit of the Sheriff's Office funds was conducted at the request of the Commissioners for the period from July 1, 2023 to April 30, 2025. The activity of the Sheriff's Office drug seizure asset forfeiture accounts was reviewed. It was noted that this is separate from the Federal Equitable Sharing Agreement. Out of \$1,259,034.80 in total expenditures, \$858,563.67, or 68.2%, were flagged for enhanced review, due to additional questions pertaining to those expenditures. The review of these funds showed the following findings:

1. Documentation & Purpose Gaps: Many expenses lacked clear linkage to drug enforcement/education

- 2. Supplanting Risks: Use of funds for recurring costs (utilities, phones, uniforms, patrol vehicle maintenance)
- 3. Cell Phone Use: Personal use acknowledged on seizure-funded phones; noncompliant
- 4. School Resource Officers (SROs): Salaries/benefits charged to seizure funds with no documented time spent on SRO or school-related duties

The recommendations made by Nesbitt & Associates to correct these findings were as follows:

- 1. Strengthen documentation: Each expense should include a memo showing purpose, nexus to enforcement/education, and assurance of non-supplanting.
- 2. Adopt written policy: Board-approved, aligned with DOJ/Treasury rules and Nebraska law.
- 3. Time-keeping for SROs: Require logs coded by function (school, patrol, interdiction).
- 4. Move recurring costs: Utilities, copier leases, phones in the General budget.
- 5. Improve procurement: Competitive bids/quotes, retain justifications.
- 6. Modernize records: Digitize invoices, tagged by fund type and case/program.
- 7. Governance cadence: Quarterly Fund Board meetings with minutes; annual report to APA; annual DOJ/Treasury certification.

In conclusion, the audit highlights serious compliance risks requiring immediate attention. By implementing the recommended reforms, the County can restore compliance, safeguard resources, and rebuild community trust. No fraud or intentional mismanagement was identified, but the current federal "do-not-spend" status underscores urgency of corrective action.

Discussion was held regarding the steps that have already been taken, in addition to plans that have been made, to correct some of the things noted in the audit findings. Sheriff Vance was present to answer questions and provide clarity on questions from the Commissioners.

Commissioner Hain led the information update regarding the meeting with the Treasury Department. She stated that the intent of the meeting was to obtain information from the Treasury Department related to documents and communication in order for the board to determine what they need to do to feel confident in signing the Equitable Sharing Agreement Certification (ESAC), and to make sure the County is in compliance. On Thursday, September 11, a Zoom meeting was held with three members of the Treasury Department, Commissioners Hain and Ahmic, and the County Attorney and Deputy County Attorney. During the meeting, questions were asked and information was received in relationship to documents that the Commissioners have or have not received. Hain stated that the compliance review was initiated November 1, 2022 and a letter was sent to the Sheriff at that time. The Commissioners did not have a copy of the letter at that time but has since obtained one. The Treasury Department is continuing their review and will complete it by December 31, 2025. Sheriff Vance stated that he wasn't contacted about the virtual meeting and feels he should have been informed so he could be present.

The Commissioners Recessed at 10:45 a.m. The Commissioners Reconvened at 10:49 a.m.

Jon Regnier, Highway Superintendent, was present with an agreement with Midwest Engineering, Inc for pipe replacement on 420<sup>th</sup> Road. He spoke with the Board last week regarding the culvert replacement.

Moved by Hain and seconded by Zabrocki to authorize the chair to sign the agreement with Midwest Engineering, Inc for a pipe replacement on 420<sup>th</sup> Road, 0.3 miles north of Old Mill Road between sections 2 & 3, Township 11 North, Range 1 East of the 6th P.M., with an amount not to exceed \$30,500.
