A regular meeting of the Seward County Board of Commissioners was convened in open and public session at 9:00 a.m. on October 21, 2025 in the Commissioner's room at the Seward County Courthouse. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

The Seward County Board of Commissioners convened on October 21, 2025 at 9:00 a.m.

The Chairperson noted that the public meeting information is posted as required by law and available for public distribution if requested.

The Pledge of Allegiance was recited.

Moved by Hain and seconded by Pekarek to authorize the chair to sign the annual service agreement with Tek84 for a warranty for a body scanner at the Detention Center.

Brandy Johnson, County Clerk, and Wendy Elston, County Attorney, updated the Commissioners on activities of their offices.

Commissioners Reports:

Commissioner Pekarek reported he met with the Zoning Administrator, met with the Sheriff, and attended a Planning Commission meeting.

Commissioner Schmieding reported he will attend a Visitors Bureau meeting and a Blue Valley Community Action (BVCA) dinner and meeting, reported that the Extension Office will be hosting a dinner meeting, and received a Zoning question from a constituent.

Mike Vance, Sheriff, and Blair Yoder, Senior Operations Manager for the Sheriff's Office, were present to discuss the update on progress toward the Equitable Sharing Agreement & Certification (ESAC) submission. Vance stated that he has been working with Commissioners Pekarek and Zabrocki to establish a purchase order (PO) policy. Previously, the Commissioners had requested that proceeds on the report be separated and listed individually, as a way to clarify the amounts more specifically. Discussion was held regarding what steps need to come next in order to proceed with signing the ESAC, as well as how to handle any claims that would potentially be paid out of the Justice Fund, in the meantime. Commissioner Zabrocki has drafted a PO policy after meeting with the law enforcement specialist at Nebraska Intergovernmental Risk Management Assn (NIRMA), and Commissioner Pekarek has drafted a PO form to begin adopting the process having a PO Committee review all claims being paid from the Drug Funds. It was decided that the ESAC will be modified as requested and brought back before the Board next week. Ahmic asked if discussions could be held prior to claims being submitted regarding potential purchases out of the Justice Fund in order for the funds to be spent before the PO system is in place, if needed.

Commissioner reports, continued:

Commissioner Ahmic reported that she received calls regarding dust control and zoning matters from constituents, noted that she will be spending some time in the Zoning Office to help out while the Zoning Administrator is on maternity leave, attended the Planning Commission meeting, received email from a constituent, reported that two Planning Commission board members' terms will be coming to an end, and she would like to put an item on next week's agenda to appoint new applicants to fill those vacancies.

Commissioner Zabrocki reported he attended a *6 Regions, One Nebraska* meeting, met with Todd Duncan at NIRMA, drafted a policy document for a Purchase Order System for the Sheriff's Office, worked on a personnel matter, and received a call regarding roads.

Commissioner Hain reported she attended the *6 Regions, One Nebraska* meeting, spoke at an Intro To Public Health class at Concordia University, drove several roads throughout the northeast portion of the county, received an email from a former employee, received a message from Staplehurst Fire & Rescue regarding a road closure, and sent out a number of invitations for an upcoming Extension Office dinner meeting.

Moved by Zabrocki and seconded by Hain to approve a utility permit for Windstream Nebraska to bore in the right-of-way at 4582 Agnew Road in the SW ¼ of Section 8 Township 12 North, Range 1 East of the 6th P.M.

After the motion, Ahmic noted that the Emergency Contact portion of the permit was not completed.

Moved by Zabrocki and seconded by Hain to amend the previous motion, and table the matter until emergency contact portion of the permit is completed.
