Jonathan Jank, Executive Director of Seward County Chamber & Development Partnership (SCCDP), updated the Commissioners on activities of the organization.

Marilyn Hladky, Assessor, and Wendy Elston, County Attorney, updated the Commissioners on activities of their departments.

Commissioner Reports:

Commissioner Hain reported that she will have a meeting with Brad Slaughter of Northland Securities regarding bonds, corresponded via email with Nebraska Department Of Transportation regarding potential grant funding for the 420th Road project and will follow up with Congressman Flood's office about potential funding as well, reported on an Executive Committee Board Meeting for 4 Corners Health

Department, led a discussion for the Juvenile Comprehensive Plan team, and met with the Veteran Service Officer regarding County Government Day.

Commissioner Zabrocki reported he received a call regarding road conditions, had a meeting with the Public Transit Director, worked on the updated SouthEast Nebraska Development District (SENDD) interlocal agreement, will attend a SENDD Board meeting, will attend a Seward City Council meeting and a will attend the Bond Issue meeting at the Seward High School.

Commissioner Ahmic reported she worked in the Zoning office, met with Captain Borges from the Sheriff's Office and the Road Department Administrative Assistant regarding the Community Safety Action Plan (CSAP), met with a staff member from the Sheriff's Office regarding a claim, had a call with Tom Nesbitt of Nesbitt & Associates, and received several calls regarding roads.

Commissioner Schmieding reported that the Visitors Bureau meeting that was scheduled was canceled due to weather and will be rescheduled.

Commissioner Pekarek reported he met with Sheriff's Office staff, along with Commissioner Ahmic, regarding a claim, corresponded with the Sheriff's Office regarding asset forfeiture questions, spoke with the Veteran Service Officer regarding County Government Day, and had a call with Tom Nesbitt of Nesbitt & Associates.

Zabrocki tabled the item on the agenda to approve the Seward County Chamber & Development Partnership (SCCDP) interlocal agreement and bylaws, as the document has not been revised. It will be added to the agenda for December 9, 2025.

Moved by Pekarek and seconded by Hain to sign the Surplus Property Disposal Request for the Detention Center.

Affirmative Vote: Pekarek, Hain, Schmieding, Zabrocki, Ahmic Motion Carried

Ahmic led discussion on the Nesbitt & Associates report regarding the Sheriff's Office. Nesbitt & Associates previously performed an independent audit of seized asset forfeiture funds for the Sheriff's Office & County Attorney's Office. Commissioners Zabrocki and Pekarek have been working with the Sheriff's Office, as well as Nesbitt & Associates, to work toward resolving some of the findings on the independent audit. Many of the items have been resolved, but the final report does not reflect those resolutions. Pekarek noted that Nesbitt & Associates would be willing to clarify specific sections of the report but asked if any of the other board members had additional questions before those clarifications are made. There was a lengthy discussion, which ended up being suspended for the 9:15 timed item on the agenda.

Roxanne Knutson, Human Resources Director and Tiffany Allen, Assistant Human Resources Director, were present to discuss Christmas Eve Hours for Seward County offices.

Moved by Pekarek and seconded by Zabrocki that County Offices close on December 24, 2025 in observance of Christmas Eve.

Affirmative Vote: Pekarek, Zabrocki, Schmieding, Hain, Ahmic Motion Carried

Sara Stenger, Detention Center Director and Andrew Truslow, Deputy Detention Center Director, introduced the new Detention Center Programs Sergeant, Jessica Cain. They were also present to request a hiring bonus for the vacant Detention Center Corrections Officer positions. There are positions that have been vacant for more than 90 days, and they are requesting a Tier Three hiring bonus. A Tier Three Bonus consists of a \$2500 bonus after one year and another \$2500 bonus after two years of employment, to be paid out of the Detention Center budget. Ahmic clarified that this request is for the two currently open positions, but this will need to be requested again if other positions come open in the future.

Moved by Hain and seconded by Pekarek to approve the request for a hiring bonus for Detention Center Corrections Officers at Tier Three, which is \$2500 after one year and \$2500 the second year of employment.

Affirmative Vote: Hain, Pekarek, Schmieding, Ahmic

Voting No: Zabrocki Motion Carried

Next, the Commissioners discussed Callback Pay for the Detention Center. Callback pay is pay for a full-time, non-exempt employee who has already left work and is called back to duty during their off-duty time, when this time does not merge with their regular shift. Stenger noted that, due to the significant shortage of Corrections Officers in the Detention Center, there often isn't sufficient coverage if an employee is not able to come in, without an employee who has already worked being called back in. They would like to offer an incentive of two times their hourly pay rate to those employees being called back in, with some exceptions, such as holiday pay. Elston stated that all policies pertaining to personnel should be county wide policies, even if they're specific to one particular department. There was extensive discussion regarding various options for Callback pay, employee incentives, budgets, and county wide policy specifics. It was decided that Human Resources will work with the County Attorney's Office and the Detention Center administrative staff to draft a potential policy and bring this back before the board.

The Commissioners recessed at 10:09 a.m. The Commissioners reconvened at 10:15 a.m.

The Nesbitt & Associates report discussion resumed. Pekarek asked the board if they have any additional questions or if there is anything in the report that they'd like more clarification on. After more discussion, it was decided that Pekarek will have Nesbitt & Associates add some additional information to help clarify some things on their final report and that will be brought back.
