WHEREAS, the Seward County Commissioners deem that it may be in the public interest of Seward County to vacate the public road described as follows: *Rokeby Road starting at the NE corner of Section 36, Township 9, Range 1E, and at the SE corner of Section 25, Township 9, Range 1E thence West approximately 2,700 feet.*

WHEREAS, the Seward County Board of Commissioners proposes to vacate or abandon this public road, which was previously declared a public road pursuant to *Neb. Rev. Stat. §39-1410* as such section existed prior to September 3, 2025; and

WHEREAS, the road is not within the zoning jurisdiction of a city of the first class.

WHEREAS, no study by the Seward County Highway Superintendent is required pursuant to *Neb. Rev. Stat. §39-1722(3)(b)*;

WHEREAS, a public hearing shall be held to determine if this road should be vacated, and,

NOW THEREFORE BE IT RESOLVED that the previously described road will be considered for road vacation at the Seward County Commissioners Meeting on \_\_\_\_\_, 2026 at \_\_\_\_\_ AM, located at Seward County Courthouse, 529 Seward Street, Room 204, Seward, NE and,

FURTHER BE IT RESOLVED that the Highway Superintendent is directed to:

- B. Serve copies of this resolution by certified mail upon the owners of the land abutting on or adjacent to the road to be vacated to the mailing to the last-known address of each owner not less than two weeks in advance of the hearing.
