**OF THE SEWARD COUNTY BOARD OF COMMISSIONERS**

WHEREAS, on the 13th day of January, 2026 at 9:15 AM, a public hearing was held in regard to the vacating of the following public road in Seward County, Nebraska;

*Rokeby Road, starting at the NE corner of Section 36, Township 9, Range 1E, and at the SE corner of Section 25, Township 9, Range 1E thence West approximately 2,700 feet.*  
and,

WHEREAS, the Seward County Commissioners feel it is in the public interest of Seward County to vacate this road; and,

WHEREAS, public notice of the proposed vacation and hearing was published for three consecutive weeks on December 24, 2025; December 31, 2025, and January 7, 2026; and,

WHEREAS, all adjacent landowners and other parties required to be notified by law have been notified by certified mail; and,

NOW THEREFORE BE IT RESOLVED that the following described road is hereby vacated and said real estate shall revert to the owners of the adjacent real estate as provided by law, effective seven (7) days after the adoption of this resolution:

*Rokeby Road, starting at the NE corner of Section 36, Township 9, Range 1E, and at the SE corner of Section 25, Township 9, Range 1E thence West approximately 2,700 feet.*

NOW THEREFORE BE IT FURTHER RESOLVED that any existing utilities located in described area being vacated are hereby granted perpetual easement for occupying said area and for maintenance of said utilities.

Regnier was present with Trever Trebilcock, Assistant Highway Superintendent, to give their recommendation for awarding the bid for a fence around the Missile Base Road Shop. There was a brief discussion regarding the options presented from the bids received.

Moved by Zabrocki and seconded by Hain to award the bid to American Fence Company of Lincoln for the fence at the Missile Base Road Shop in the amount of \$79,782.55 to be paid from the Inheritance Fund.

Regnier & Trebilcock presented a one-year rental agreement with NMC CAT for a skid loader.

Moved by Hain and seconded by Zabrocki to authorize the chair to sign the one-year rental agreement with NMC CAT for a skid loader.

Regnier led discussion on seeking funding options to purchase an engine for a motor grader. Currently, the Road Department has two motor graders that are out of commission due to engine issues. As previously decided by the board, one will be repaired and one will be sold as surplus property. The Road Department does not have the funds in their budget to cover the cost of the repairs. Caterpillar has given them the option of purchasing a remanufactured engine for \$80,033.78 or rebuilding the existing engine for \$92,311.53. It was suggested that the proceeds from the sale of the surplus motor grader be deposited in the Inheritance Fund.

Moved by Zabrocki and seconded by Hain to purchase a remanufactured engine for the motor grader from NMC CAT for \$80,033.78, to be paid out of the Inheritance Fund.

The next item for discussion was potentially seeking bids for a used motor grader. The purchase of a used motor grader was previously discussed, and at that time, it was decided to have the County Attorney's office review the government cooperative purchasing process through Sourcewell. There is the potential for a government contract through Sourcewell that pertains to the *rental* of used equipment, but nothing in particular that specifies the *purchase* of used equipment in this situation. It was decided that the fastest and easiest option at this time would be to seek bids for a used motor grader.

Moved by Hain and seconded by Zabrocki to authorize the Highway Superintendent to go out for bids for a used motor grader.

Affirmative Vote: Hain, Zabrocki, Schmieding, Ahmic Motion Carried

Brandy Hafer, Public Transit Director, was present to discuss the consideration of quotes received from Safefleet and Ehlers Electronics to transfer the camera system from the Public Transit bus to the Public Transit van. There is currently a Public Transit bus that isn't functional, so the camera needs to be moved to the van instead. Safefleet originally installed the equipment but would have to fly a technician out to move it, resulting in a significantly higher quote than using a local business to do it. Hain asked if the warranty would be voided if someone other than the company that installed the equipment moved it. Ahmic asked if there is funding for this within the Public Transit budget, but Hafer reported that she plans to use her Sinking Fund for this expense. Schmieding asked if Ehlers offers a warranty on their work, to which Hafer noted she would have to find out.

Moved by Hain and seconded by Zabrocki to approve the quote from Ehlers Electronics to transfer the camera system from the Public Transit bus to the Public Transit van, up to \$2000, to be paid out of the Public Transit Sinking Fund.

Hafer then presented the Commissioners with the potential fare increase for Public Transit. Due to the possibility of funding cuts for Public Transit, she has been exploring different options to help with budgeting. She discussed the old fares in comparison to the potential new fares and how she arrived at those amounts. There was discussion regarding the various options for charging different fares for different services. Due to there being several factors to consider for this, Zabrocki suggested tabling this discussion for today and having Hafer come back with some other options.

Next, Hafer updated the Commissioners on Public Transit funding. She explained some ways she was able to lessen her expenditures in the last couple of months. Ahmic asked

Hafer to bring an estimate back to the board when she comes back for the discussion of fare increases, of what she thinks the budget is projected to look like toward the end of the fiscal year.

Ahmic, along with Heidi Fleischman, Road Department Administrative Assistant, were present to discuss considering seeking bids for a Feasibility Study as part of the Safe Streets and Roads for All (SS4A) Grant. The estimated cost of the application is anticipated to exceed the maximum cost before a bid is required.

Moved by Hain and seconded by Zabrocki to approve the request to seek bids for the Feasibility Study, with bids to be opened February 3, 2026.

### **Commissioner Reports:**

Commissioner Hain reported she listened to part of the Nebraska Association of County Officials (NACO) webinar regarding legislative bills, received an email from Matt Howe, an Aide for Senator Hughes, regarding infrastructure funds and noted that the 420<sup>th</sup> Road paving project would be a potential fit for this grant opportunity, which is a federal grant through United States Department of Transportation (USDOT) known as the Better Utilizing Investments to Leverage Development (BUILD) grant. She also reported she reviewed the NACO newsletter and noted some American Association of Retired Persons (AARP) Grant Opportunities that the county could qualify for in several different areas, and had a meeting with a constituent regarding a legislative bill related to domestic violence.

Commissioner Zabrocki reported he attended the Emergency Management Governance Board meeting, attended a Nebraska Intergovernmental Risk Management Assn. (NIRMA) roundtable, sat in on a Perma-Zyme webinar, had a meeting with the Sheriff, and plans to attend a Seward City Council meeting.

Commissioner Ahmic reported she worked in the Zoning office, attended a Milford City Council meeting, worked with the Road Department Administrative Assistant on a Safe Streets and Roads for All (SS4A) Grant agreement, worked on Emergency Management items, including the Emergency Preparedness event planned for later this year, worked with Soarin Group regarding expenses for CentralSquare, put together the SS4A Committee, spoke with Seward County Chamber & Development Partnership (SCCDP) regarding an AARP grant, followed up with a representative from the Daughters of the American Revolution (DAR), attended a Perma-Zyme webinar, and forwarded applications that have been received so far for the vacant Emergency Manager position to the other board members.

Commissioner Schmieding reported he will attend a Tree Board meeting, attended a Seward City Parks & Recreation Board meeting, attended an Extension Board meeting, will attend a Visitors Bureau meeting, a Blue Valley Community Action (BVCA) Zoom meeting, a Visitors Bureau annual banquet and Problem Solving Court graduation, and attended a Womens Club meeting.

Ahmic led the discussion on Emergency Management contact. She noted that she and Zabrocki have been checking the emails during the position's vacancy, and once Commissioner Pekarek returns from vacation, he will take over checking those emails until someone is hired. There was discussion on what the plan will be if there is a snow event or other kind of emergency during the time the position remains vacant. In the event of a snowstorm, the Sheriff will work with the Highway Superintendent, and they will call Ahmic with updates on the road conditions. In any other kind of emergency

event, Ahmic, the County Attorney, the Sheriff, and in some instances, the Highway Superintendent, will work together to form an appropriate plan.

In regard to the timeline for hiring an Emergency Manager, the job opening has been posted, and some applications have been received. Ahmic reported that she emailed the applications that have been received so far to the other board members and asked for their feedback. Interviews for the position are expected to begin taking place later this month.
