The Commissioners Recessed at 9:08 a.m.

The Commissioners Reconvened at 9:10 a.m.

Marissa Pfile, Zoning Administrator, presented a proposal from Marvin Planning and Consultants for Zoning Consultation Services. Previously, the board discussed hiring a consultant to assist with questions pertaining specifically to Zoning regulations. The Zoning Administrator would still utilize the County Attorney's Office for legal advice. There was discussion about some of the verbiage in the proposal. Pfile is going to have the verbiage on the proposal changed and bring it back next week.

Jon Regnier, Highway Superintendent, and Trever Trebilcock, Assistant Highway Superintendent, were present to discuss options for a water trailer and roller/packer for Permazyme application on county roads. Trebilcock reported that he has called multiple places in search of a water trailer tank to rent or borrow for the application process, and he presented a list of options for either renting or purchasing the necessary equipment. The Permazyme application on county roads will begin as a trial, but Regnier noted that the water trailer could be used outside of the dust control application for other road projects. The trailer they found does not include an appropriate pump mechanism, so Ahmic asked them to find a quote for the appropriate equipment and bring it back to the board with that information.

The Commissioners recessed at 9:28 a.m.

The Commissioners reconvened at 9:30 a.m.

Ahmic added an emergency item to the agenda to clarify Seward County's contribution amount toward the Better Utilizing Investments to Leverage Development (BUILD) Grant for the 420th Road Paving Project. The reason for an emergency item being that there is a deadline for the grant and the grant writers cannot continue until they have confirmation of Seward County's contribution amount.

Moved by Hain and seconded by Zabrocki to add an emergency item to the agenda to discuss the Seward County match amount for the BUILD Grant.

Brandy Hafer, Public Transit Director, was present to give an update on Public Transit Department Funding. Previously, the board had asked her to bring a number of unique individuals who utilize Public Transit's services, as well as how many trips each of those individuals have taken in the last year. Hafer compiled a spreadsheet of different numbers of people and kinds of trips they took in 2025. Jeffrey Baker, former Public Transit Director, was present for the discussion. Baker gave a history of the Public Transit program, answered questions and offered to assist Hafer with any Public Transit needs she may have. Ahmic commented that she would like the number of unique riders and how many rides each of those individuals took, noting that this information would be helpful to see how many people we are utilizing the service. Hafer was asked to compile the requested information and bring it back next week.

The Commissioners recessed 10:07 a.m.

The Commissioners reconvened at 10:09 a.m.

Regnier and Barb Armstead, Deputy County Attorney, updated the Commissioners on activities of their departments.

Commissioner Reports:

Commissioner Hain reported she had a virtual meeting with Commissioner Ahmic, the Road Dept. Administrative Assistant, and the grant writer for the BUILD Grant. She worked gathering information and letters of support for the BUILD Grant, met with the Road Dept. Administrative Assistant to work on grant related tasks, and gave updates on grant deadlines.

Commissioner Zabrocki reported he attended a Seward City Council meeting, attended a Nebraska Intergovernmental Risk Management Assn. (NIRMA) roundtable meeting, attended a Region 5 Board meeting, attended an Apace board meeting, and had a liaison meeting with the Sheriff.

Commissioner Ahmic reported she attended a Milford City Council meeting, attended a Dorchester City Council meeting in regard to Seward Saline Solid Waste Management, attended a Garland City Council meeting, had a Community Safety Action Plan (CSAP) meeting with the Road Dept Administrative Assistant and Captain Borges from the Sheriff's Office, attended Emergency Manager interviews, had a meeting with the Highway Superintendent and Commissioner Hain, had an Emergency Preparedness Committee meeting, attended three Seward County Chamber & Development Partnership (SCCDP) meetings – the Personnel and Policies board, Executive Board meeting, and one to discuss the Emergency Preparedness Event, met with a Staplehurst Village Board member regarding solid waste management, attended a grant meeting with the Road Dept Administrative Assistant, Commissioner Hain and the grant writer, got a reply from Senator Storer regarding tax relief and noted that she asked the board to reach back out and schedule a meeting at the beginning of April, and reported that her sister, who is an Air Force Veteran, has a colleague who is looking for recent college graduates looking for a three year opportunity with the Department of the Air Force performing civilian work.

Commissioner Schmieding reported he called on residents from his district and will attend a Visitors Bureau meeting and a Blue Valley Community Action meeting.

Commissioner Pekarek reported he attended interviews for the Emergency Manager, attended a Southeast Nebraska Emergency Management meeting, and emergency preparedness event meeting

Armstead tabled the agenda item to authorize the Chair to sign the amendment to extend the CentralSquare Interlocal Agreement.

The Hiring Committee presented their recommendation for the Emergency Manager/Zoning Assistant to the board. There was discussion on the hiring process, with Ahmic asking for clarification on the process moving forward in order to remain consistent. Armstead advised that the name of the candidate needs to be provided.

Moved by Zabrocki and seconded by Schmieding that the board approve the offering of a position to Ms. Eckles as Emergency Manager and Zoning Assistant, and Human Resources be given the authority to perform background checks necessary to proceed with the appointment.

Moved by Hain to enter into Executive Session at 10:44 a.m. to discuss personnel.

Motion died for lack of second.

For the emergency agenda item regarding the BUILD Grant, Ahmic stated that in a previous application, they indicated that the county would contribute \$78,737.00. That is the amount that was originally estimated for engineering.

Moved by Hain and seconded by Pekarek to approve the local match for the 420th Road Paving Project in the amount of \$78,737.00 to be paid out of the Inheritance Fund.
